Minutes of the meeting of Fairfield Parish Council held in Fairfield Community Hall on Thursday 9th July 2015 at 7:30 pm

71 Apologies for Absence

71.1 Apologies received from Councillor Bidwell (holiday), Councillor Mitchinson (holiday) and Ward Members Councillor B Saunders (meeting) Councillor J Saunders (holiday).

72 Disclosures of Interest and Dispensation requests

72.1 No disclosures of interest and no requests for dispensation were received.

73 Council Minutes

73.1 Minutes of the meeting held on Thursday 11th June 2015 had been circulated to all councillors and it was

RESOLVED

That these minutes be agreed as a true and accurate record of the proceedings and be duly signed by the Chairman.

74 Public Participation

74.1 No members of the Public requested to speak.

75 Parish Crime Update

- 75.1 PCSO Joseph Passby introduced himself as the new PCSO and advised that between 12th June and 9th July there were no new recorded crimes. However, there was one solved crime for violence against the person.
- 75.2 PCSO Joseph Passby agreed to investigate the inconsiderate parking around Fairfield, in particular along Bronte Avenue.

76 Central Bedfordshire Council Ward Members Report

76.1 Councillor Dixon advised that a decision on the planning applications on the land on the former pig unit and the Land East of Hitchin Road, South of 159 Hitchin Road (proposed new school) would be made by CBC this month.

77 West Drive

The work started last week to the repairs and improvements to the surface of West Drive. The contractor is Adrian Sinfield. He will start with the planings work section 3, the fareast end of the works nearest to Fairfield Park and then work his way west towards Arlesey. He will create a limestone blinded road planings surface across the grass section. This will be ramped up and down so that there are appropriate gradients where the path meets the perimeter bridleway, and then continue until the junction with the section 2. Once he has completed section 2, he will be repairing section 3 including the whole of the scar down the middle. During this phase he will have to dig out this scar before he can patch it and during this he will try to stop people falling in this scar by placing cones all along it. Apart from this work he will block the area where he is working with heras panels. There is no legal closure necessary because West Drive is not yet of any highway status. FPC has expressed concern that the motorcycle problem will get worse as the bollards have been removed and are only being replaced with four posts. Take away delivery drivers on scooters have already been spotted using this as a short cut.

78 Speed Limit in Fairfield

78.1 CBC is waiting for their contractor Amey to provide details of the process and associated costs. Councillor Dixon advised that there may be some money available from the match funding scheme and he agreed to ask. **Action: SD**

79 Signs

- 79.1 Hertfordshire Highways has advised that pedestrian warning signs near to Thorne's nursery may be viewed as a low priority so suggested asking CBC to use S106 money. It was agreed to wait until after the decisions on the planning applications on the land on the former pig unit and the Land East of Hitchin Road, South of 159 Hitchin Road had been made.
- 79.2 FPC is waiting for a response from Hertfordshire Highways on new proposed directional signs to Fairfield.

80.1 FPC is waiting for a response to the pre-application consultation sent to CBC. Councillor Dixon to chase up. **Action: SD**

Area between front balancing pond and the front of Fairfield Hall

71.1 FPC had received three quotations (MBS, Maydencroft and James Mosley). Following a discussion it was

The area needs clearing and Maydencroft's quotation was considered best value as it also included removing the self-set horse chestnuts.

72.1 MBS has quoted the same price as last year to cut the hedge. Following a discussion it was

That the contract would be awarded to MBS at a cost of £105.

REASON

The hedge needs clearing and MBS's quotation was considered good value as they can do the work when on site doing other work.

77 Section 106 Agreement – Disputed ownership and possible transfer of land including the Orchards.

- 77.1 Councillors Dack. Hank and Mitchinson attended the surgery with the Rt Hon Alistair Burt, MP on Sunday and it was discussed that as there are TPO (Tree Preservation Orders) on the Orchard Trees, CBC can write to the landowner advising then that they must maintain them. If the landowner does not respond then CBC can send someone in to maintain them. It would also have to be CBC who would initiate a CPO (Compulsory Purchase Order).
- 77.2 Peter Fraser, CBC has advised that Hotbed has no comment on further plans on the sale of the lease.
- 77.3 Following a discussion, it was

RESOLVED

That FPC would invite Blandy and Blandy to a meeting at Fairfield to discuss the next steps. The legal costs would be limited to £2,000 at this stage.

REASON

So FPC has a strategy and can start working towards a conclusion. Action: BD

78 Orchards

78.1 It was agreed to get quotations to cut down laurels in the west orchard so that the apple trees can be exposed. As this work needs to be done during the summer it was agreed to delegate powers to Councillor Dack to award the contract with a budget of £535. **Action: BD**

79 Public Art Money (S106)

79.1 A meeting with FPRA and CBC's appointed artist has been arranged for Tuesday 21st July at 7.00pm in the Community Hall.

80 Transferring Community Hall to FPC

80.1 Linden Homes has sent an update of their list for information Linden Homes had hoped to be further on but unfortunately had to reschedule the maintenance man to w/c 20th July. With regards to the loft wall, Linden Homes has a proposal to increase the u value using a sprayed insulation. Templars will be acting on FPC's behalf to approve this method.

81.1 Encore, the new Managing Agent, has suggested to CBC that as PJ Livesey remain responsible for preparing the area for adoption then CBC request that PJ Livesey make the surface fit for purpose.

82 Fairfield Hall

82.1 NHBC is carrying out the repairs to the roof and continue to uncover more problems.

83 Roof at Beeton Court

Work is expected to be starting soon to resolve this issue.

84 25 Kipling Crescent

84.1 CBC is investigating the allegation of an Aldwyck tenant running a car sale business from the premises in breach of the tenancy agreement.
