

## Minutes of an ordinary Meeting of Fairfield Parish Council held virtually on Zoom on Thursday 10<sup>th</sup> December 2020 at 7:00 pm

### 225 Apologies for Absence

225.1 Apologies for absence from were received from Ward Members Councillors B Saunders (BS), S Dixon (SD) and N Harris (NH).

### 226 Chairman's Notice

226.1 FPC's statement on commitment to openness and transparency is available on FPC website.

226.2 The Chairman reminded everyone that under FPC's policy of transparency and openness, permission needs to be requested if anyone wants to record part of whole of the meeting. FPC's current Zoom settings do not allow recording without the Chairman's permission.

### 227 Disclosures of Interest and Dispensation requests

227.1 Councillors Dack and Reynolds declared an interest in item 230.2 as both are personal friends of the applicant. It was agreed they would stay for the discussion but would not participate in any discussion or vote.

Councillors Dack and Andrews declared an interest in item 243.1 (Councillor Dack is a Trustee/Treasurer and Councillor Andrews is a Trustee/Chairman of the Community Hall Trust). It was agreed they would both stay at the Zoom meeting as there is no decision or discussion.

227.2 No written requests for dispensations for declarable interests.

## 230 Planning Applications

### 230.1 CB/20/04235/FULL 155 Bronte Avenue

First and second floor rear extension.

FPC had no objections to the basic principle of the application based on the information available and providing there are conditions that the construction complies with the Fairfield Neighbourhood Plan Design Statement.

### 230.2 CB/20/04257/FULL 39 Hardy Way

Single storey rear extension.

FPC had no objections to the basic principle of the application based on the information available and providing there are conditions that the construction complies with the Fairfield Neighbourhood Plan Design Statement. However, there is concern about the slate and brick and the applicant should be made aware that these **MUST** match the existing slates and bricks.

### 230.3 CB/TRE/20/00600 East & West Orchards, Fairfield

Works to trees protected by a Preservation Order: Various works at East & West Orchards, Fairfield to CB/10/00010/G1&G2

This is an application from FPC, so no comments were made.

### 230.4 CB/20/04459/FULL 12 Dickens Boulevard

Proposed first floor rear extension.

FPC had no objections to the basic principle of the application based on the information available and providing there are conditions that the construction complies with the Fairfield Neighbourhood Plan Design Statement.

### 230.5 CB/TRE/20/00683 Fairfield

Works to trees protected by a Preservation Order MB/99/00001: Various works including removing, reducing and removing deadwood of various trees.

FPC had no comments on this and will leave it to the CBC Tree Officer to carry out appropriate investigations.

### 230.6 CB/20/01519/LDCE Urban Central Park, Dickens Boulevard, Fairfield

Lawful Development Certificate Existing: Remove canopy and re-site in park

FPC had no objections.

## 231 Planning Decisions

### 231.1 CB/20/03603/FULL 5 Burton Close

Single storey rear extension.

FPC objected to this application as it does not comply with the Fairfield Neighbourhood Plan Design. If CBC Officers are minded to recommending it for approval, FPC requested it was called into the Development Management Committee for determination.

**Full permission granted by CBC on 1<sup>st</sup> December 2020.**

### 231.2 CB/20/03668/FULL 5 Paxton Drive

Demolish existing conservatory and build new infill extension.

FPC objected to the application due to the insufficient information about the specifications of the proposed materials, which must comply with the Fairfield Neighbourhood Plan Design.

**Full permission granted by CBC on 19<sup>th</sup> November 2020.**

## 232 Central Bedfordshire Council Ward Members Report

### 232.1 In his absence, Councillor Dixon sent a written report from the Ward Councillors: -

Covid-19 – Thankfully, we have seen another week of reducing cases in the ward. To the end of last week, there were around ten cases across the Stotfold, Langford and Fairfield area. That said, we have seen a considerable increase across Central Bedfordshire and our tier in the same period, so must continue to be extremely vigilant in guarding against the continued spread of the virus. While greater granularity is not available, PHE have confirmed that there are not any patterns of concern to them in the ward.

The Community Champions continue to do excellent work in keeping the most up to date messaging pushed into our communities, but any additional help Councillors can undertake with re-posting and the like, would be gratefully received. A comprehensive range of information on Covid related matters is available on the front page of the CBC website, including the most recent business focussed grants. FPC to include in next newsletter. **Action: BD**

Vicky Head has recently been appointed as Director of Public Health for Central Bedfordshire, Bedford Borough and Milton Keynes, following Muriel Scott's retirement.

Traffic Management Committee – A petition has been received requesting the installation of a pelican crossing by the school on Dickens Boulevard following a recent incident involving a nine-year child and a vehicle. The committee meet on the 15<sup>th</sup> December to consider the request. This can be watched on the CBC webcast.

West Drive Contamination – Contractors have cleared a large element of the overgrown area off West Drive / Eliot Way in the last few days. This follows concerns raised by FPC that asbestos had been dumped on the area some years ago. The investigation workers on the land, which is owned by CBC, were asked for by Councillor Dixon some months ago. Councillor Dixon apologised that no notice was given for the works and he now awaits feedback on what was found before CBC consider further what role, if any, the area might play in fulfilling the ambitions of the village for allotments and a Garden of Reflection or Remembrance. FPC to include in next newsletter. **Action: BD**

Icknield House – An investigation was recently raised by CBC officers, following a resident suggestion that the property should have been demolished as part of the original Fairfield Master Plan. However, under planning application MB/07/02184/Full, consent was granted for Icknield House to be retained. Accordingly, there is no breach of planning control. Fuller details can be seen on the CBC planning web pages by searching the above application number.

Article 4 Application – On the 5<sup>th</sup> January, the CBC Executive will consider the responses to the recent consultation on the Article 4 application. Any members wishing to watch the debate can do so via CBC webcast.

Local Plan – The final round of hearings started on Tuesday 8<sup>th</sup> December and runs through to 18<sup>th</sup> December. Only those registered to speak may do so, but as with the Executive, members of the public can watch discussion via the CBC webcast. Details of the timings of the hearings are available via the CBC website. It is hoped that the Inspectors decision on the plan will be made early in 2021.

Tree and Hedge Planting – On the 8<sup>th</sup> December, a scheme to make monies available to community groups and Parish Councils was approved at the CBC Executive. Run through the existing Community Grants team, applications are now open for the balance of the current planting season and for schemes running into next season. The scheme is also to be shared with applications from CBC projects and is not just confined to tree & planting. Any scheme that helps to boost biodiversity and/or facilitate carbon capture will be considered and assessed by expert Officers from CBC. Projects that create wider co-benefits will be welcomed. A recent suggestion for urban areas, included the development of a green wall which might be more appropriate for a town centre. Further information will be sent out next week and applications can be started via the CBC website.

All the Ward Councillors wished everyone a very merry Christmas and a happy new year.

232.2 Mobile CCTV – Councillor Dixon is still investigating this and hopes to arrange a meeting with interested parties in January.

### 233 **CBC Local Plan**

233.1 Councillor Dack reported on Part 2 of the Local Plan inquiry concerning area SRA3 East of Arlesey that took place in the afternoon. Silke Gruner, CSA Environmental Associate Landscape Architect and Urban Designer represented FPC. The recording will be on the CBC for all to watch and Councillor Dack will make people aware when this is available. **Action: BD**

### **234 The Royal British Legion**

234.1 Covid meant that many of the usual collections for The Royal British Legion had to be curtailed and they are literally millions down in funding. Normally the Fairfield Community Church appeal raised £400 for them and FPC had planned on a collection at the service that unfortunately had to be cancelled due to the Covid-19 Pandemic. FPC to discuss the recent appeal from the Legion.

Following a discussion, and with a unanimous vote, it was

**That FPC would donate £400.00.**

**To support The Royal British Legion**

The clerk to arrange payment. **Action: KH**

### **235 Christmas tree Collection Point**

Following a discussion, and with a unanimous vote, it was

**RESOLVED**

**That FPC will provide this service again.**

**REASON**

**To provide somewhere people can dispose of Christmas Trees easily.**

Councillor Dack to liaise with Hislop & Co Horticulture for disposal of trees and for the signs to be displayed. **Action: BD**

### **236 Benches at Cricket Ground**

236.1 Following a discussion, and with a unanimous vote, it was

**RESOLVED**

**That FPC would purchase five Elwood™ Recycled Material Seat from Glasdon at a cost £3,510.95 + VAT subject to approval from the Cricket Club (As long as the Cricket Club are in agreement with the proposed style then FHMC are happy for this to go ahead).**

**REASON**

**To provide benches for the Community to enjoy.**

The clerk to purchase in time for agreed installation date. **Action: KH**

236.2 Quotations for installations were received from B2B, Hislop & Co Horticulture and Maydencroft. Before a decision could be made, the clerk to clarify that the quotes for B2B and Maydencroft both were for one concrete base and the concrete would be transported using wheelbarrows to prevent any damage done to the Cricket Pitch. **Action: KH**

### **237 Two replacement Silver Birch Trees in the Community Garden**

237.1 Quotations for new trees were received from Grasslands Nursery, Todd's Nursey and Trees Direct. It was agreed that Councillors Andrews would ask FHMC and the Bowls Club to consider replaced these trees with an alternative native species of trees that will last longer. **Action: NA**

### **238 A replacement tree in the Urban Park**

238.1 Following a discussion, it was agreed Councillors Andrews, Khatwa and Reynolds will set up a Working Group to look into the replacement of the Urban Park tree. Two known horticultural experts from Fairfield will also be invited to join this Group. It was noted that any new proposal will need permission FPRA. **Action: NA / VK / NR**

### **239 March 2021 Meeting**

239.1 Following a request from the Clerk it was agreed to move the March meeting to 3<sup>rd</sup> March 2021, if required.

### **240 Orchards**

240.1 FPC has requested permission from FHMC to do the suggested work by Bob Lever on the trees and planning permission has been applied for as some trees have TPOs.

240.2 Councillor Daffarn confirmed that the Plum Trees will be planted on 12<sup>th</sup> December and invited her fellow Parish Councillors to attend if they were available.

### **241 Proposed Garden of Reflection**

241.1 CBC has cleared the site and will advise FPC the results of the survey as soon as it is completed.

### **242 Allotments**

242.1 Councillor Reader advised he had met with the CEO of Axiom and he was incredibly supportive of the proposed Allotments.

Lisa White, CBC Policy Manager Leisure, Libraries and Countryside has given guidance on what needs to be done next to secure the land. Councillor Reader has asked Councillor Dixon to make Assets aware that FPC are hoping to run the Garden of Reflection and Allotment projects concurrently and asked him to find out what we should we do next regarding registering FPC's plan with them.

FPC has requested CDS quote to design the allotments as part of the Garden of Reflection design. FPC will meet with CDS in the New Year to look at the areas.

### **243 Transfer of the Community Hall**

243.1 Nothing new to report.

### **244 St Luke's Chapel**

244.1 Councillor Dack advised that it had been sold to a developer.

### **245 Additional Storage for Cricket Club / Green Storage Building**

245.1 Nothing new to report.

### **246 Proposed Trim Trail**

246.1 FPC is waiting to hear if Hotbed will grant permission to install some equipment on their land.

### **247 Neighbourhood Watch**

247.1 Councillors Dack, Hunt and Reynolds met with three representatives from the newly formed NHW Group and were extremely impressed how quickly and professionally they had set up the Group.

The Police and CBC have supplied some NHW signs and the NHW Group will shortly agree where these will be displayed.

A leaflet is planned to be delivered to all households in Fairfield.

FPC stressed that it represented the whole of Fairfield and therefore requested that the NHW was for the whole of Fairfield and this request was agreed.

Additionally, there are twelve volunteers to undertake Street Watch training.

## 248 Crime figures
